# 187/2425 Village Issues

The clerk is to chase up North lincs council regarding the state of the footpaths. B Reed also mentioned the state of the footpaths down Island Road.

The clerk also questioned if a rent invoice needs to be sent. It was agreed by all to keep the rent at the same rate. Clerk to send an invoice.

### 188/2425 Ward councilors update

1. There has been a change in cabinet and there is now an emphasis on filling in potholes, with anything considered dangerous that is to be repaired within 24 hours.

Main arterial roads are priority and then the b roads.

- 2. The tree planting grant has enabled 180000 trees to be planted.
- 3. Waste government declared that you cannot have more than 3 bins. Food waste must go in the brown bin and there will be an increase in brown bin collection.
- 4. They are currently working on the winter warmth project.
- 5. There has been a review called over the potential closure/ downsize of Scunthorpe hospital.
- 6. North Lincolnshire has also made representation over the potential closure/ downsize of Goole hospital.
- 7. There are major road works to take place in Crowle at the beginning of August and there will be a 2-week road closure.
- 8. North Lincolnshire council have said that there must be solar panels installed on all new buildings.
- 9. It is the 400<sup>th</sup> anniversary of the drainage of the isle by Mr Vermuyden. It was suggested that we look at putting an event on to commemorate the event. C Newton suggested creating an information sheet.
- 10. Grants- If a micro grant is awarded the pot gets topped up at the end of the year. A maximum of £300 can be awarded per application.

The Keadby thermal grant awards up to £2000 to constitute bodies such as football teams, sports teams etc. and there is no requirement for 10% match funding

The SSE thermal meeting is in July.

Currently bus trips are not covered however Cllr Bint has proposed that they should be considered if the trip is within North Lincolnshire.
